The theme of this special issue is Service-learning and its integration into teacher education. In addition, the two book reviews in this issue present timely resources for educators who seek more information on civics and service-learning. Clearly, this special issue contains a collection of research articles that will add substance and value to the discourse in service-learning and teacher education and contribute substantially to the literature in the field. In addition, the breadth of topics in this special issue should generate interest among scholars, researchers, as well graduate students, teachers and as community leaders.

My sincere appreciation goes to the guest editors of this Special Issue, Drs. Alan Bates and Miranda Lin, whose leadership and dedication in working tirelessly on this special issue yielded articles characterized by substantive quality, timeliness and relevance. I also applaud their passion in servicelearning, which motivated them to propose this special issue to the New Waves Journal.
